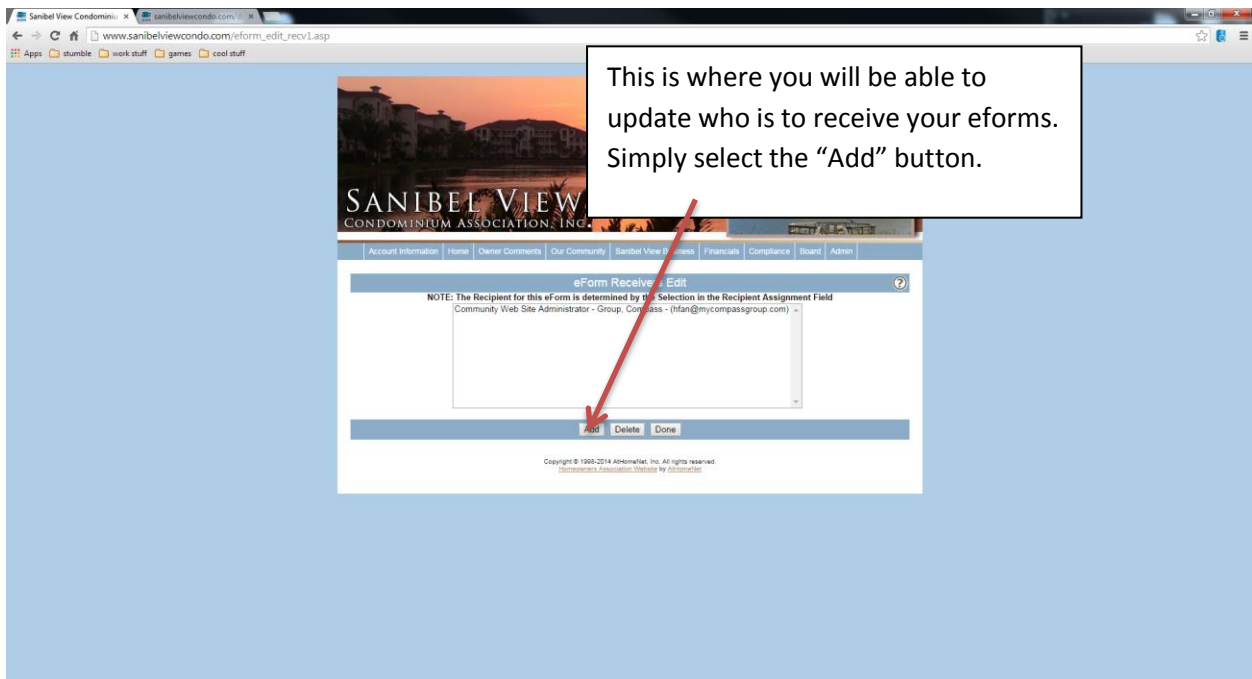
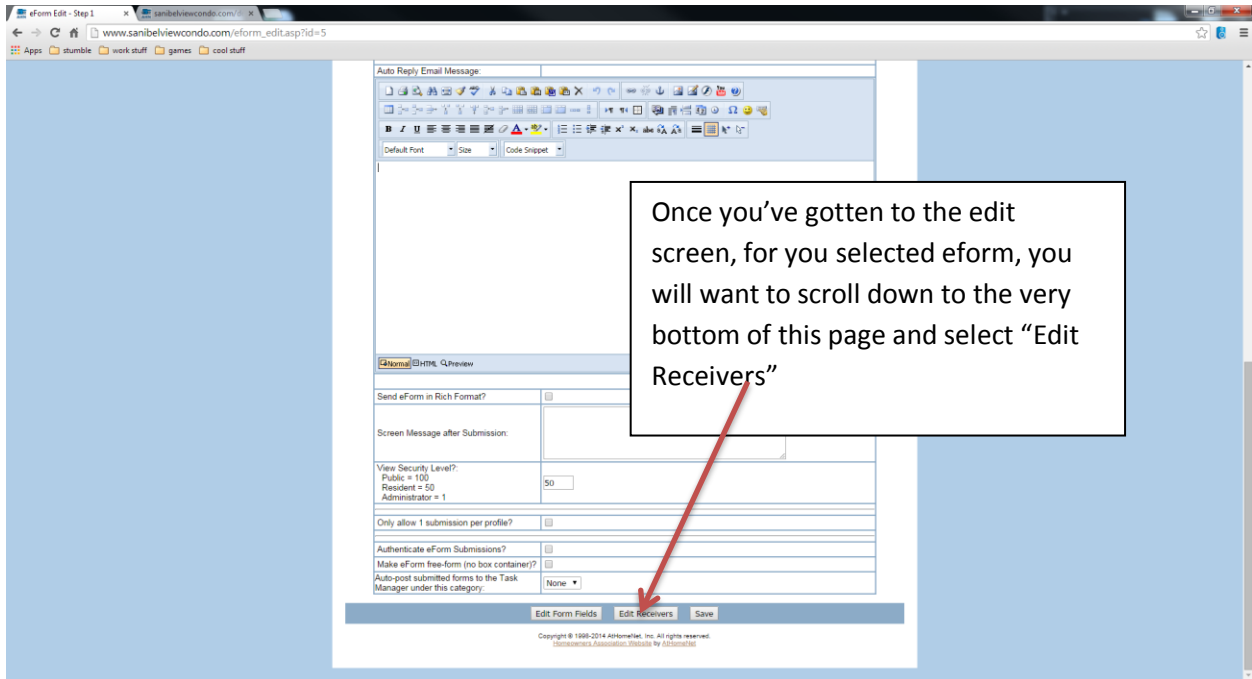


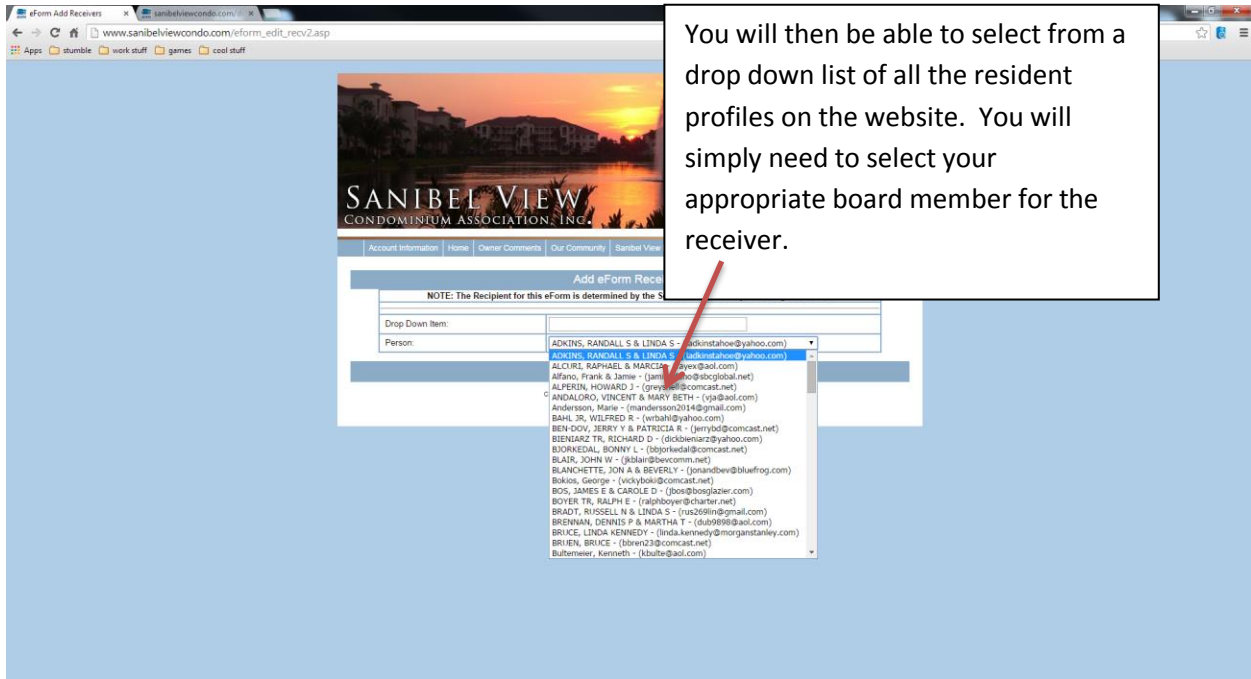
Start by going to the eform section in the admin part of the menu options, then select the "Add, Edit, Delete eForms" button
